

<u>Minutes of the Pre-bid meeting for 'E - Tender for Shuttle Services (Bus Transport Service) for</u> <u>StockHolding Office at Mahape, Navi Mumbai' held at Mahape office of STOCKHOLDING on 20th</u> <u>June 2023 at 11.00 a.m.</u>

The following points were discussed and clarified to the vendors:

- 1) In case of breakdown of a vehicle, the agency will be responsible for repair and maintenance of the vehicle and will arrange alternate vehicle. StockHolding will not pay any type of compensation for maintenance/damage of the vehicle.
- 2) Firms registered under National Small Industries Corporation (NSIC) / Micro, Small and Medium Enterprises (MSME) for specific trade are exempted from EMD and shall upload the scanned copy of necessary documents. The Bidder shall upload the copy of the document.
- 3) Schedule of the bus trips operating currently are attached to this document. The schedule is indicative only and for reference purpose. No. of trips can increase or decrease as per requirement of StockHolding.
- 4) Manufacturing Year of Vehicle deployed at StockHolding should not be more than six years.
- 5) Scope of Work :
 - 1. Minimum 2 (Two) Nos. of 49 Seater Bus should make 3 trips (approx.) each in the morning and evening as per our requirement (Monday to Friday).
 - Minimum 2 (Two) Nos. of 17 Seater Bus should be exclusively for StockHolding on full time, making 25 trips(approx.) throughout the day, i.e. from 06:00 AM to 11:00 PM, (Monday to Saturday).
 Please Note: One trip means SHCIL House to Ghansoli Station and Ghansoli Station to SHCIL House.

Shuttle timing will be decided by StockHolding and is subject to change as per requirement of StockHolding. Any decision in this regard by StockHolding shall be final, conclusive and binding on the Bidder.

This facility is being used by approximately 800 (Eight Hundred) Employees, Guests and Outsourcing staff of StockHolding and its subsidiary companies extensively and all the Shuttle service will be used to its full capacity.

Clarifications on the queries received up to and during the pre-bid meeting are uploaded on the website. The Corporation will not be obliged to answer the queries received after the Pre-bid meeting.
